- 8. Scheme of selection:-Selection to the posts will be considered on the prescribed essential qualification mentioned, and the same are the bare minimum and the mere possession of the same does not entitle candidates to be considered for the post and the higher



qualifications and experience will be preferred. However, if the number of applications received for the post is large, then the Institution Authority reserves the right to lay down higher criteria for the purpose of short listing of the candidates.

- 9.
