G.S.R. 1460.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of accruitment to Group 'D' posts in the Kalawati Saran Childrens' Hospital. New Delhi, namely ;—

- 1. Short title and commencement—(1) These rules may be called the Kalawati Saran Children's Hospial (Group 'D' posts) Recruitment Rules 1979.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application.—These rules shall apply to the posts specified in column 2 of the Schedule annexed to these rules.
- 3. Number, classification and scale of pay.—The number of posts, their classification and the scale of pay attached thereto, shall be as specified in columns 3 to 5 of the Schedule aforesaid.
- 4. Method of recruitment, age limit, qualifications etc.— The method of recruitment, age limit, qualification and other matters relating to the said posts shall be as specified in column 6 to 14 of the said Schedule.
- 5. Persons appointed as peons to undergo training as Home Guards.—Notwithstanding anything contained in these.

shall undergo compulsory training as Home Guards for a period of three years

Provided that the Commandant General, Home Guards, may, having regard to the performance of, and standard of training achieved by, any person during the period of training, reduced such period to two years for reasons to be recorded in writing.

- 6. Disqualification. No person,
 - (a) who has entered into or contracted a marriage with a person having a spouse living; o
 - (b) who, having a spouse living has entered into or contracted a marriage, with any person, shall be eligible for appointment to any of the said posts;

Provided that, the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of these rules.

- 7. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do; it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons or posts.
- 8. Saving.—Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes and the Scheduled Tribes and other special categories of persons 10 accordance with the orders issued by the Central Coversions for
