- 5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do. it y order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class egory of persons.
- 6. Saving.—Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required provided for the Scheduled Castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons, to lance with the orders issued by the Central Government from time to time in this regard.
