#### **CIRCULAR**

### Subject: List of recommended applicants for Compassionate Appointment - Reg.

The objective of the Compassionate appointment Scheme is to grant appointment on compassionate grounds to tide over the family of deceased Government Servant from financial hardship and to relieve the family of the Government servant from financial destitution.

2. Keeping in view the objective of the Scheme, and to ensure complete transparency, 100 point scale for assessment of applications issued by Ministry of Health and Family Welfare has been followed is adopted for considering the cases of compassionate appointment and based on the recommendation of the Screening Committee, the Director, LHMC & SSKH has approved the appointment of following dependent members of deceased Government Servant on Compassionate Ground as per list below:



## Report of the Committee

A Committee for Compassionate Appointments was formed by Director, Lady Hardinge Medical College vide order number F.48/Comp. Apptt./Admin - II/2021/5803 dated 01-07-2021.

Constitution of the Committee was as following:

Mandate of the committee was to examine the cases in terms of DOPT OM No. 14014/6/94-Estt (D) dated 9<sup>th</sup> October 1998 as amended from time to time and as per the 100 points scale for assessment of the applications issued by the Ministry of Health and Family Welfare.

### Background:

- a) Objective of the Scheme is to grant appointment on compassionate ground to a dependent family member of the Government Servant dying in harness or who is retired on medical grounds, thereby leaving his family in penury and without any means of livelihood and to relieve the family of the Government Servants concerned from the financial destitution and to help it get over the emergency.
- b) The "Government Servant" for the purpose means a Government Servant appointed on regular basis and not one working on daily wages or casual or apprentice or ad-hoc or contract or re-employment basis.
- c) OM No A-12012/01/2019-Estt.IV dated 15<sup>th</sup> March 2021 prescribes a 100 point scale for Assessment of applications received for consideration for appointment on compassionate grounds. Some other OMs and FAQs have been issued by the Government of India to provide clarifications and guidance.
- d) One hundred and sixteen (116) pending applications were presented to the Committee which were pending for varying duration with the Department.
- e) The data submitted and transcribed was verified by the Administration.

The Committee applied the following criteria to assess the applications:

- a) Only those applications were considered for which the financial status of the applicants had been assessed by the DLWC and reports were available. As the information received was old in some cases, an undertaking was taken from the applicants for updation with respect to family members and other criteria laid down in the guidance documents. Applications for which the clarifications were not provided by the applicants were not considered for the present Assessment.
- b) The applications received from the family of the employees retired voluntarily from this Institution and applications received from the family of the deceased T.S. employees who are not eligible were not considered. (i.e. the Cases No. 48,56,59,62,65&116 (6 cases)).
- c) Application received from a dependent on a Government servant herself appointed on compassionate grounds against the demise of her spouse may not be considered to qualify as a Government servant as defined for the purpose.
- d) "Married daughter" was also to be considered for compassionate appointment subject to conditions:
  - That she was wholly dependent on the Government servant at the time of his/her death in harness or retirement on medical grounds.
  - ii. She must support other dependents members of the family.
- e) "Married son" was also to be considered for Compassionate Appointment as per the Office Memorandum No. 14014/02/2012-Estt (D) dated 5<sup>th</sup> September, 2016, issued by Department of Personnel & Training.
- f) The applicant for compassionate appointment should be eligible and suitable for the post in all respects under the provisions of the relevant recruitment rules of the post offered to him/her. Therefore Applicants who were "Minor" were not considered. (i. e the case No. 95 (1 case))
- g) Current Family pension received by the dependent family and confirmed by the DLWC/ Accounts department/Admin/ bank statement was considered.
  - Cases where pension had not been disbursed due to nonsubmission of required documents from the applicants were not considered and kept pending. (i.e. the Cases No. 72,78 &92 (3 cases)).
  - ii) There were a few cases where the family pension was stopped due to the death of the spouse and there remaining family members were not eligible to receive the pensions as per rules. In such cases,

the points attributable to pension were not granted to the Applicant. However, to avoid disadvantage to the family because of no fault of theirs, the Score was calculated out of applicable 80 (Eighty) points and was then normalized to 100 points for comparison with other applications. (i.e, Cases No. 8,15,17,24,25,30,32,37,52,79,88,93,94,100,106,107,108,111 (18 cases))

- h) Pension and Terminal benefits due to the family but not yet released due to administrative reasons were considered for calculation of score as per the guidelines.
- Eligible dependents were considered according to the DLWC report and update received from the applicants.
- j) Liabilities of the applicants were considered as per verification by DLWC. However, liabilities, like loans, claimed without documentary evidence were not considered for score.
- k) Additional points as prescribed by the Government OM were given to the applicants like five points to applicant spouse, two points to applicant daughter and one point for each year for applications received during period 2015-2019.
- In some of the cases, the applicants were not responded for the letter issued by the DLWC for verification of the financial status of the family of the deceased employees. The cases were not considered in the present Assessment. (i.e. Cases No. 11, 23,34,42,57,60 (6 cases)).
- m) In case a widow who apply for compassionate appointment, does not fulfill educational requirement of a post is considered for compassionate appointment, she can be appointed only against a multi-tasking staff post provided the appointment authority is satisfied that she can satisfactorily perform duties of the post with the help of some on job training.

Some of the observations made during the Scrutiny of the applications which need clarifications from competent authority are as following:

a) In some cases, the spouse of the deceased employee is in regular employment either in this Institution, or in other Central/State Government and may not be facing financial constraints as per the intent of the scheme which is to relieve the family of the Government concerned from financial destitution. (i.e. Case No. 12,20,38,64,77,80,89,93,98, 102,104,107 (12 cases))

- b) In some cases, spouse of the deceased employee is in a well paid private job as per declaration and were not is financial crisis. (i.e. Case No.99 (1
- c) In a case, one dependent member (son) had applied for a compassionate appointment against deceased father while another dependent son had applied for compassionate appointment against the deceased mother where in both father and mother were Government servants in the Institution. Intent of the Scheme is to provide assistance to the Family and not the individual dependents and thus, only one application for the family may be considered. (i.e. cases No. 107& 111 (2 cases))

The Committee taking into consideration of the above and the Mandate, has prepared the consolidated data sheet for 116 cases with score points for each case, as per the guidelines issued by Ministry of Health & Family Welfare for adopting 100 point scale.

- a) The Merit list as per the Score sheet may be considered by the Administration for appointment against the decided available vacant positions according to the eligibility criteria.
- b) Some available vacancies may be kept in abeyance to comply with any directions in Sub-judice cases.
- c) Cases which have not been considered due to non-submission of certain documents by the family for payment of the family pension and other terminal benefits by the Institution may be kept pending for subsequent committee as and when formed.
- d) Case which do not get an appointment based on current Score sheet may be considered on re-application without any additional bonus points as per guidelines


