OFFICE ORDER

Reference Scrutiny and Counselling for allotment of Departments to Medical, Non-PG Junior Residents (NPGJRs) and the documents verification of selected Non-PG Junior Residents for Dental & Oral Surgery Department which was held on 15/04/2026. - (i) The candidates will collect their offer appointment letters from **Admin I Section, LHMC** for joining the duties as per terms & conditions of appointment letter. The date of joining time will be **07 days** from the date of issuance of this order on the Official website of this institution.
- ii) The candidates will bring all relevant original documents at the time of joining in this Institution.
- lii) The terms & conditions of offer appointment letter for all candidates for information is attached herewith as per **Annexure I**.

ANNEXURE I

**Terms & Conditions of offer appointment to the tenure post of Non-PG Junior Resident
(Medical + Dental)**

1. The tenure of Non-PG Junior Resident is for **one year including any service rendered as Non-PG Junior Resident earlier on ad-hoc/regular basis (irrespective of in parts or one go)** in any Government Institution (initial appointment on selection will be for 6 months extendable to another 6 months on recommendation of concerned HoD).
2. The scale of pay admissible to the Non-PG Junior Resident in the Level-10 (Rs. 56100/- to Rs 177500/-) of the pay matrix and Non-Practicing Allowances as per orders issued by the Government from time to time.
3. Private practice of any kind, including laboratory and consultancy practice is not allowed.
4. **Resignation by the employee – conditions for acceptance :**
The notice of resignation tendered by the Non-PG Junior Residents, given either with immediate effect or 10 days of prior notice period for resigning from the post with full applicable pay, shall not be come into effect Suo moto until or unless a communication regarding acceptance of resignation is issued by the Administrative Division with approval of the Competent Authority. If the resignation is given with immediate effect, the Non-PG Junior Resident has to deposit 10 days' salary in lieu of the notice period.
However in the interest of patient care, the Non-PG Junior Resident has to render at least 10 days service before giving 10 days' notice or paying 10 days salary in lieu thereof before resignation. If the Non-PG Junior Resident submits the resignation & starts absenting himself/herself before the acceptance of the resignation, he/she will be treated as absent from duty. In such cases, the Competent Authority reserves the right to terminate the service without any notice period and without any 10 days salary and the pending salary will be forfeited and no experience certificate will be issued.
5. **Termination of service by the employer-**
The Appointing Authority, reserves the right of terminating the services forthwith in case of violation of rules/terms & conditions of the offer appointment letter, without any notice period and without any 10 days salary. In such cases, the pending salary will be forfeited and no experience certificate will be released.
6. The Non-PG Junior Resident will be allowed one day off in a week in rotation subject to exigencies of work.
7. **Leave Entitlement to the post of Non-PG Junior Resident on Regular/Tenure/Ad-hoc basis:** *only 2 ½ days leave are admissible for the whole per calendar month during the tenure and not be entitled any other kind of leave.*
8. The Non-PG Junior Resident is appointed for LHMC & Associated Hospitals but in the exigencies, you will be liable to serve in any part of India or outside.
9. You will be required to undergo compulsorily training in Bio-Medical Waste Management (BMWM) under the aegis of the Department of Microbiology of the Institute at the earliest and comply the same during your work in LHMC. The salary will be released only on production of the training certificate in **BMWM**.
10. In accordance with the relevant rules in force in regard to the recruitment to service under the Government of India:-
 - a. No person who has more than one wife living or who, having a spouse living, contract a second marriage, though such marriage is void by reason of its taking place during the life-time of such spouse, shall be eligible for appointment to service, provided that the Central Government may, if satisfied that there are special grounds for so ordering exempt any person from the operation of this rule.
 - b. No such woman whose marriage is void by reason of its taking place during the life-time of her spouse or who was married shall be eligible for appointment in service unless the Government of India has granted exemption to such a woman in accordance with this

rule after being satisfied that there are special grounds for so ordering.

This offer of appointment is, therefore, conditional upon satisfying the requirement and furnishing declaration in the form enclosed to this letter. If, however anyone does not fulfil the above conditions and desires to be exempted from the above-mentioned rules any reason, one should make a representation in this behalf immediately. This offer of appointment should not, in that case, be treated as cancelled and a further communication will be sent in due course, if upon consideration of representation, it is still decided to offer the appointment to post of Non-PG Junior Resident.

11. The hostel accommodation may be provided subject to its availability. In case of allotment, use of heavy penalty will be imposed on the defaulter apart from realization of electrical charges as per prevailing rates. The Junior Resident shall vacate the accommodation before expiry of term otherwise the action will be taken as per rule.
12. Adherence to the rules, discipline and code to conduct prevailing in the Institution, wearing of white coats and the name plates while on duty is compulsory.
13. Other terms and conditions of service will be governed by the relevant rules and orders that may be issued from time to time.
14. No travelling allowance shall be paid for joining the post.
15. The appointment is subject to medical fitness.
16. If you accept the offer on the above terms and conditions, you are requested to intimate your acceptance to the undersigned and report yourself for duty immediately or within a period of 07 days as per date notified in the result published on the Official website of this Institution along with the following documents, failing which the candidature may be liable for cancellation in case of non-reporting within given time period.
 - a. Original Certificates of Educational Qualifications;
 - b. Certificate of Age;
 - c. Registration Certificate of Delhi Medical Council;
 - d. Declaration of Marital status in the prescribed pro-forma;
 - e. Medical Certificate of fitness in the prescribed form;
 - f. Certificate in the case of SC/ST/OBC/EWS/PWD candidate in the prescribed form (OBC candidates are required to submit certificate regarding OBC status & Non-Creamy Layer status as per prescribed format issued by Govt. of India).
17. If any declaration given or information furnished is proved to be false or it has been found that any material information is wilfully suppressed, the incumbent will be liable for removal from service and other action as deemed necessary.
18. In violation of the terms & conditions of offer appointment letter, the last month salary & experience certificate will not be provided.
