Minutes of Meeting

A meeting of the committee was held on **16.07.2026 (Thursday) at 10.30 a.m** in the office of Director, under the Chairmanship of Dr. Yuvraj Deepak Kumar, AMS SH-III to evaluate the applications of the applicants who had applied for compassionate appointment including the data related to pension and terminal benefits of the applicants. The following members were present in the meeting: -

1. Dr. Anupam Prakash, Director Professor of Medicine Department
2. Dr. Shiv Prasad, Professor of Psychiatry Department

The Committee members discussed about the steps in the process of evaluation and raised their concern for the following points prior to initiating the evaluation process: -

1. The data related to pension and terminal benefits of the applicants was incomplete and, in some cases, not provided by the concerned office with a remark that the record is not available, the committee is of the view that this is a very serious remark and need to be re-looked into and the same should be furnished by the concerned department within a week.
2. If the above record is not available, the concerned department should give a declaration regarding the same duly signed and stamped by the HoD/DD(A) so that further needful can be done at the earliest.
3. Committee is of view that since, the committee consist of only two members it becomes difficult at times when one of them being a clinician is not available in the meeting also technicalities regarding the accounts and administration cannot be fulfilled by a junior most secretarial assistant, hence, it was decided that two senior members one having knowledge of accounts and other a controlling authority form the administration side should be co-opted in the committee after taking approval from Director.
4. Few of the applicant application is without date, that needs to be confirmed from the records.
5. A proforma for evaluation of the dependent cases on the basis of the laid down 100-point scoring criteria for compassionate appointment for each applicant should be finalised at the earliest.
