

- ii) The candidates will bring all relevant original documents at the time of joining in this Institution.
- lii) The terms & conditions of offer appointment letter for all candidates for information is attached herewith as per Annexure I.


## **ANNEXURE I**

### **Terms & Conditions of offer appointment to the Ad-hoc post of Non-PG Junior Resident**

1. Ad-hoc appointment is given for only 89 days. However, the appointment may be subject to further extension maximum of 180 days, based on the satisfactory performance report from the concerned Head of the Department/availability of the vacancy/availability of regular candidate.
2. The candidates appointed on ad-hoc basis should complete their tenure of 89 days. In case of resignation tendered by the Non-PG Junior Residents, given either with immediate effect or 10 days of prior notice period for resigning from the post with full applicable pay, shall not be come into effect Suo moto until or unless a communication regarding acceptance of resignation is issued by the Administrative Division with approval of the Competent Authority. If the resignation is given with immediate effect, the Non-PG Junior Resident has to deposit 10 days' salary in lieu of the notice period. However in the interest of patient care, the Non-PG Junior Resident has to render at least 10 days service before giving 10 days' notice or paying 10 days salary in lieu thereof before resignation.
3. **If the Non-PG Junior Resident submits the resignation & starts absenting himself/herself before the acceptance of the resignation, he/she will be treated as absent from duty. In such cases, the Competent Authority reserves the right to terminate the service without any notice period and without any 10 days salary and the pending salary will be forfeited and no experience certificate will be issued.**
4. In case of violation of rules/terms & conditions of the offer appointment letter, the Competent Authority reserves the right to terminate the service without any notice period and without any one month salary.
5. His/her services can be discontinued any time without assigning any reasons.
6. **The scale of pay admissible to the Non-PG Junior Resident in the Level-10 (Rs. 56100/- to Rs. 177500/-) of the pay matrix and Non-Practicing Allowances (NPA) as per orders issued by the Government from time to time.**
7. **Leave Entitlement: only 2 ½ days leave are admissible for the whole per calendar month during the tenure and not be entitled any other kind of leave.**
8. The appointment will be further subject to:-
  - (A) Production of Medical Certificate of fitness and character certificate from two Gazetted Officers.
  - (B) Production of the following original certificates along with an attested copy of each in proof of:-
    - (i) Degree/Certificate of educational qualifications.
    - (ii) Certificate of Age.
    - (iii) Submission of marital declaration to the effect that he/she is not have more than one spouse living/or is not married to a person who is already having spouse living.
    - (iv) Certificate in case of SC/ST/OBC/EWS/PWD in the prescribed format from the competent authority and as per Govt. of India's rules/instructions.
9. Relieving Order from the present employer, if any.
10. If any declaration given or information furnished by the candidate false or he/she wilfully suppressed any material/information, his/her services will liable to be terminated.
11. **Other terms and conditions of service will be governed by the relevant rules and orders that may be issued by the Institution from time to time.**



12. He/she should note that he/she should have to adhere to the rules, discipline and code to conduct prevailing in the Institution wearing of white coats and the name plates while on duty is compulsory.
13. The Head of the Institution has full discretion to forward or withheld any of his/her application for appointment elsewhere.
14. **If he/she accept the Offer on the above conditions, he/she shall communicate his/her acceptance to the undersigned and report himself/herself for duty within 07 days failing which the offer of appointment will be cancelled without any further notice.**
15. No TA or other allowance will be paid to him/her for joining the post.
16. The appointment will be further subject to the fulfilling the provisions under Sub-section (6) of section 15 of the Delhi Medical Council Act regarding registration with the Delhi Medical Council/DDC.
17. The service conditions of Non-PG Junior Resident will be governed by the rules and instructions issued by the Ministry of Health & family Welfare in this regards.
18. **He/she is required to undergo Bio-Medical Waste Management (BMWM) training from the Department of Microbiology of this Institution. His/her first salary will be released only after submission of certificate of successful completion of the aforesaid training.**
19. The Non-PG Junior Resident is appointed for LHMC & Associated Hospitals but in the exigencies you will be liable to serve in any part of India or outside
20. This ad-hoc appointment will not bestow any claim for regular appointment to the post of Non-PG Junior Resident.
