Eligibility	Officers under the Central Government or State Government or Union territory administrations or Autonomous or Statutory organisation or Public Sector Undertakings or Universities or recognised research institutions:- (a) (i) holding analogous posts on regular basis in the parent cadre or department; or (ii) with five years of regular service in the grade rendered after appointment thereto on a regular basis in level-10 in the pay matrix (Rs. 56100-177500) or equivalent in the parent cadre or department; and (b) possessing the following qualifications and experience: Post-graduate in clinical embryology (graduated with full time program with minimum four semesters) from a recognised University with one year human ART laboratory experiences in handling human gametes and embryos; or Ph.D. holder full-time Ph.D. project shall be related to Clinical Embryology or assisted reproductive technology or fertility from a recognised University with two years of human ART laboratory experience in handling human gametes and embryos; or Medical graduate (MBBS) or Veterinary graduate (BVSc) with a post-graduate degree in Clinical Embryology (full-time program) from a recognised University with three years of ART laboratory experience in handling human gametes and embryos; or Post-graduate in life sciences or Biotechnology with a minimum of one year of on-site, fulltime clinical embryology certified training with four years' experience in handling human gametes and embryos in a registered ART level 2 clinic.
