There will be three prizes plus 3 consolation prizes for each category as follows:

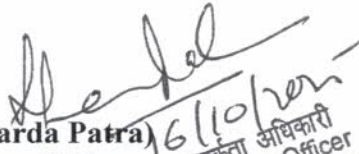
1st Prize:	Rs. 2500/-
