 - Passed M.B.B.S/ B.D.S from a recognized Medical/Dental College in India or has qualified in the FMG examination in case of foreign medical graduates
 - b. Candidates who have appeared in NEET-PG 2025 / NEET-MDS 2025 examination.
 - c. Permanent Registration with Delhi Medical Council / Delhi Dental Council/State Medical / State Dental Council or Acknowledgement for application for the same before the last date of applications for this advertisement.
 - 2. Criteria for ineligibility :
 - a. Those candidates who have already done one year Non-PG Junior Resident (irrespective of in parts or one go) in any Government Institute are not eligible.
 - 3. Reservation will be given in the posts strictly in accordance with prescribed norms/rules issued by Govt. of India from time to time.
 - SC/ST candidates to submit copy of community/caste certificate from designated authority.
 - ii. OBC candidates should submit valid OBC Certificate for applying post under the Central Government of India as per OM No. 36036/2/2013-Estt. (Res-I) dated 31.03.2016 of DOPT, Ministry of Personal & Public Grievance & Pensions, New Delhi with Non Creamy Layer Certificate issued in present financial year i.e. 2025-26.

 - **4.** Crucial date of determination of eligibility with reference to age, educational qualification and experience etc. will be the last date of submission of application.
 - 5. The candidates are advised to ensure that they fulfil the eligibility criteria as mentioned in the advertisement before applying for the post.

- 6. The interested candidates may apply and send their duly completed application form addressed to Deputy Director(Admin), LHMC and Associated Hospitals, Shaheed Bhagat Singh Marg, New Delhi-110001 through SPEED POST/ REGISTERED POST or directly by Hand to R & I Section, LHMC & SSKH. The last date of application submission will be 20.01.2026 up-to 05.00 P.M. No application will be accepted after last date & time of application received either through post or by hand. The envelope containing the application form must super scribe "Engagement of Non-PG Junior Resident in LHMC (Medical or Dental)" in bold capital letters. This Institution will not be responsible for any Postal delay.
- 7. Prescribed Application form duly filled & signed (Annexure-I) should be accompanied with self-attested copies of mark sheet of Final M.B.B.S / B.D.S examination, DMC / DDC / State Medical / State Dental Council registration certificate (or acknowledgement of application), Internship completion certificate, category certificate, 10th class passing certificate and copy of Aadhar card, PAN card, Score sheet of NEET-PG 2025 / NEET-MDS 2025 as applicable and FMG exam result in case of foreign graduates. The candidate must affix one recent passport size photograph in application form.
- Incomplete application in any respect will not be considered. Only application received
 in response to this Advertisement in the prescribed form will be considered and no
 other application in response of any other Advertisement shall be considered.
- If an applicant has not submitted valid certificate in support of the concerned SC/ST/OBC/EWS/PwD category, the candidature of such candidates shall be considered under general category.
- 10. List of the shortlisted eligible candidates shall be displayed on the Website of LHMC (http://lhmc-hosp.gov.in) as well as on its Notice Board.
- Before counselling, scrutiny of documents will be done as per the eligibility for joining of duties in this Institution.
- 12. Selection Process for eligible candidates:The selection after counselling, will be based on the Rank obtained in NEET-PG
 2025 / NEET-MDS 2025 examination.
- 13. Results: Category wise results along with waiting list will be made available on the Website of LHMC as well as on its Notice Board.
- 14. At initial stage, appointment letters will be issued against clear cut vacancies in order of merit, thereafter, appointment letters will be issued to remaining candidates against anticipated vacancies according to tenure completion of current incumbents.
- Permanent Registration certificate of DMC/DDC/Acknowledgement of application will be mandatory for joining, if selected.
- 16. Terms and conditions of appointment
 - Tenure: Initially the duration of Non-PG Junior Residency will be for 6 months and it may be extendable up to maximum 1 year as per the recommendation of the HoD.
 - b. Pay Scale: The scale of pay admissible to the Non-PG Junior Resident in the Level-10 (Rs. 56100/- to Rs. 177500/-) of the pay matrix + other allowances as admissible as per orders issued by the Government from time to time.
 - Other service conditions will be applicable as specified by the Govt. of India from time to time.
 - d. Appointment letter to selected/waitlisted candidates will only be given after verification of their original documents.

- 17. Notice period for Resignation: 10 days prior notice period shall be required for resigning from the post. The candidates may choose to pay equal amount in lieu of the notice period.
- 18. No TA/DA will be paid for this purpose.
- 19. Selected candidates will report for duty within a period of 07 days from the date of issue of the appointment letter. Candidature may be liable for cancellation in case of their nonreporting within given time period. Request for extension shall be considered in exceptional cases as per the discretion of Director.
