Introduction

The College of Nursing, Lady Hardinge Medical College and Associated Hospitals, New Delhi is a pioneer institute for nursing education in India. It was started as a School of Nursing in 1916 and was upgraded to College of Nursing in September 2007 with the initiative and financial support of Ministry of Health and Family Welfare. The College of Nursing is academically affiliated to University of Delhi and is recognized by Indian Nursing Council. The primary objective of the college is to improve the quality of nursing education keeping in mind the growing need for quality nursing care.

The prestigious medical college has two Associated Hospitals, Smt. Sucheta Kriplani Hospital (formerly Lady Hardinge Hospital) and Kalawati Saran Children Hospital, from where the students gain excellent practical experience.

Course of studies

The College of Nursing offers B.Sc. (Hons.) Nursing Course of four year's duration.

Philosophy of the College of Nursing

The College of Nursing believes that:

The B.Sc.(Hons.) Nursing Course of four year's duration should be planned around the nursing care need of the society as well as the educational needs & personal development of nursing students. The Primary focus of the educational programme is to prepare the student nurse for professional nursing practices in all fields.

Another focus of the course is to offer an educational base needed for continuing nursing education.

The faculty of the college accepts the responsibility of helping the students to adjust to new situations and provides them with opportunity, which contributes towards development of the student as a person, responsible citizen & competent practitioner.

Objectives of Educational Programme:

The aim of the course is to select students with potential for professional Nursing and provide the needed environment and experience.

To develop an understanding of the biological and behavioral Sciences applied in meeting the Nursing needs of individual patients and acquire ability to plan and implement it in care of the sick, prevention of disease, promotion of health, rehabilitation and in meeting emergency situations in co-operation with others. To develop understanding and ability to use communication skills effectively and maintain a good inter-personal relationship.

To create an understanding of the Nurse's individual responsibility as a member of society and as a member of nursing profession and ability to participate in changing needs of the society.

To develop an appreciation and awareness of the need for continuing education for growth and development of self and profession.

To develop an understanding of nursing with a view to generate new perspectives and innovative approaches to deal with problems encountered in nursing and health field.

To equip the students with sound theoretical knowledge by integrating other science subjects like behavioral science and biological science.

Admission and Reservation:

Regular admissions are made in the month of July each year. The number of admissions shall be according to the number of seats available. In the present academic year, the number of seats available for admission are as follows: -

• Number of Sanctioned seats -	62
• Number of seats/admission from J & K under Supernumerary Quota -	8
Total	70

Reservation of seats for candidates belonging to different categories as per Central Govt. Rules.

- ❖ 15% seats are reserved for SC candidates.
- ❖ 7.5% seats are reserved for ST candidates.
- ❖ 27% seats are reserved for non-creamy layer OBC candidates. Reservation would be applicable to the castes mentioned in the Central list of OBC.
- ❖ 10% Reservation for Economically Weaker Sections (EWSs) as per government Rules.
- **Five percent (5%) seats are reserved on horizontal basis for PwD/Differently abled candidates:** (only for locomotor disabilities of lower limbs between 40% to 50% as per INC admission criteria).

The Indian Nursing Council has resolved in its meeting that:-

"For Disabled candidates: 5% disability reservation to be considered with a disability of locomotor to the tune of 40% to 50% of the lower extremity."

Further, it has also been resolved that a committee to be formed consisting of medical officers authorized by medical board of State Government and a Nursing Expert in the panel which may decide whether the candidates have the disability of locomotor of 40% to 50%.

- **Five Percent (5%) seats are reserved on horizontal basis for the candidates belonging to Children/Widows of Armed and Para Military Personnel (CWWAPP) Category.**

The seats of CWWAPP category will be filled in the following order of priority:-

Priority VIII : Wards of Serving Personnel.

Priority IX : Wives of Serving Personnel.

ELIGIBILITY FOR ADMISSION

1. Minimum Qualification

- 1.1 Candidate seeking admission to First Year B.Sc. (Hons.) Nursing course must have passed the Examination as listed below:-

Senior Secondary School Certificate Examination/Indian School Certificate Examination (10+2) or its equivalent from recognized Board with a minimum of 45% marks in aggregate (40% marks for SC/ST & OBC candidates) of four subjects including English, Physics, Chemistry and Biology, provided the student has passed in each subject separately.

- 1.2 Minimum age requirement is 17 years as on 31st December 2025.

- 1.3 Only women candidates are eligible to apply for the course.

Procedure for forwarding application: -

A candidate seeking admission in B.Sc. (Hons.) Nursing course shall submit an online application for [(NEET (UG)) - 2026 exam obtainable from the NTA website:- <http://neet.nta.nic.in> along with fee as mentioned there in.

NOTE: False Certification / False information / concealment of information provided/ done by the candidate will result in the cancellation of the candidature at any stage of selection or during the course of study.

2. Method of Selection

All candidates are required to appear for written test [(NEET (UG)) - 2026 which will be conducted by NTA (National Testing Agency).

Admission of candidates made process of common counselling followed by verification of original certificates in the office of the Principal, College of Nursing, Lady Hardinge Medical College, New Delhi-110001 as per the list provided by MCC.

INSTRUCTIONS TO THE CANDIDATES

1. Admissions of the candidates shall be made by the process of verification of original certificate at in the office of Principal, College of Nursing Lady Hardinge Medical College, New Delhi-110001. The attendance of all candidates reporting for verification shall be recorded between 10 - 11 am and after that process of verification / admission shall start.
2. The verification process shall take place only on personal appearance of the candidate. In the event of any hospitalization of the candidate, an authorized representative may be permitted and is subject to production of (i) medical certificate from a hospital (ii) authority letter from the candidate along with attested photo of the representative (iii) documents original.
3. Attending the verification session does not ensure admission to the course. The admission process shall be done as per the displayed MCC list of unreserved and reserved category candidates as per extant reservation rules.
4. No TA / DA is admissible for appearing in the verification session.
5. The process of admission shall stop once the requisite seats are filled. The admission process shall be done as per the displayed merit list of unreserved and reserved category candidates as per extant reservation rules.

At the time of verification / admission for B.Sc. (Hons.) Nursing Course, the candidate must be present along with the following original documents:

- MCC Allotment letter
- Aadhar card/Number
- Class X board examination certificate
- Class XII marks-sheet
- Class XII provisional certificate/original certificate
- Recent character certificate (within last 6 months)
- SC/ST certificate (in the name of the candidate) issued by the competent authority (if applicable)
- Recent OBC non-creamy layer certificate in the name of the candidate issued by competent authority (if applicable)
- Transfer certificate from board/college as well as migration certificate from board/university is required from those students who have passed senior secondary examination from outside Delhi
- Disability certificate (if applicable)
- Certificate for CWWAPP category (if applicable)
- Certificate for EWSs

After verification of original certificate those candidates who are found eligible for admission to B. Sc. (Hons.) Nursing course are required to deposit fee Rs. 9605/- through Demand draft in favour of “**Director LPMC & Associated Hospitals**”.

Admission will be provisional till the candidate is declared medically fit by the Board of medical examination constituted by College Authorities. If candidate is found medically unfit, her admission shall stand cancelled with immediate effect.

Hostel/Mess

Residing in the Hostel is compulsory. Hostel accommodation will be provided from the day the academic session starts. Free furnished double seated accommodation is provided. Membership in the mess is compulsory. Mess charges (Rs. 3000/- p.m. subject to amendment) to be paid every month. Students have to abide by the hostel rules.

Stipend:

During fourth year internship period B. Sc. (Hons.) Nursing students receive an amount of Rs. 13150/-/- per month as internship allowance from the Government.

Discontinuation:

Students found guilty of misconduct, who are found breaking rules and regulations of the Hostel or causing indiscipline or whose performance is unsatisfactory and those who do not make progress in study will be issued warning in the first two instances. If the mistake is repeated, disciplinary action will be taken under the rules.

Simultaneous Attendance at other Courses:

No student will be permitted to pursue other courses simultaneously than those prescribed by the College nor will she be given permission to appear in any examination other than that conducted by the University of Delhi for B.Sc. (Hons.) Nursing.

Recreation:

In the hostel, Indoor and outdoor games are provided for their recreation. Reading materials are also provided in the recreation room of the hostel.

Student Nurses Association:

The students have an organization of their own which is affiliated to the Student Nurses Association of India and further affiliated to Trained Nurses Association of India. They are encouraged to arrange extra-curricular activities and thus to accept leadership roles. There is a contributory Fund which is utilized for sending delegates to conferences and to arrange social and cultural activities throughout the year.

B.Sc. (Hons.) Nursing Syllabus:

The purpose of the Course is to assist students to become professional nurses committed to promotion of health, prevention of disease, care during illness and rehabilitation of the clients. The curriculum has been planned to provide in-depth knowledge to enable the candidate to function effectively in various nursing health care settings at individual, family and community levels in urban as well as rural areas.

Other Information

1. Students are expected to follow the rules of the College and Hostel and failure to do so will lead to disciplinary action.
2. Hostel accommodation is available for students in the College Hostel.
3. The College provides transport facilities for student's field work but when it is not feasible, students will have to use public transport at their own expenses.
4. When students are posted outside Delhi for field experience/field work, expenses shall be borne by the students.
5. Students are advised not to keep heavy cash, gold jewellery and costly electronic items in their rooms.
6. Candidates selected for admission to B.Sc. (Hons.) Nursing are required to make arrangement for purchasing the uniform for clinical experience.
7. Students are required to buy text-books and stationery for their course.
8. Educational excursions are arranged from time to time, the cost of which shall be borne by the students.
9. Any disputes related to admission, will be dealt under Jurisdiction of Delhi Courts only.

Hostel Rules and Regulations:

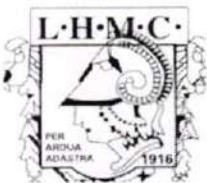
1. Student should co-operate in the upkeep of the Nurses Hostel and its good name.
2. Student should keep their rooms tidy and clean. They are fully responsible for the furniture and other articles supplied for their use.
3. Proper locks are to be put on the room doors, Jewellery and Expensive items should not be kept in the rooms. The institution will not be held responsible for the loss of any valuables.
4. The names of occupants of the rooms should be put on the doors.
5. Student should remain in the room allotted to them. Change of room should not be done without permission from the Principal through the Home Sister.
6. Care should be taken not to leave the taps open, lights and fans on, in the rooms when not required. Carelessness will render them liable to disciplinary action. Heaters are not to be used in the rooms. Cooking is not permitted in the Rooms.
7. No, relatives/children are permitted to enter the rooms.
8. Student can go out during off duty time, subject to the following: -
 - a) Should not leave the hostel before 7.00 AM.
 - b) Should return to the hostel by 7.30 PM.
 - c) Should sign in the outgoing register.
 - d) Classes/duty are not missed.

9. Night roll call will be taken daily at 8.00 PM. All students must be present. After the night roll call students should go to their respective rooms. Silence must be maintained in the Hostel after 10.00 PM.
10. Students are permitted to visit Home/Guardian's home on a written request by parent/guardian. However, issuing of sleeping out passes will be at the discretion of the Principal.
11. Visiting time from 4 pm to 7:30 pm on week days.
 - (a) Visitors should be entertained in the visiting room only and not outside the Hostel.
 - (b) Students are permitted to receive only those Male visitors whose names are given in the visitors list at the time of admission.
 - (c) All visitors should write their names and relationship with the student in the Visitors Book.
12. Meals will only be served in the Dining Room at fixed timings. Students should be properly dressed when going to the dining Room/Visitors Room. No meals will be brought to the rooms except in sickness.
13. All complaints regarding repairs or hostel problems should be made to the Home Sister on duty. Students should not directly deal with the workers.
14. Uniforms must be:
 - Neat and clean.
 - Of proper length
 - Clean shoes
 - No Jewellery and make up on duty.
15. The Hostel environment should be kept clean (rooms, bathrooms verandahs etc.)
16. Students should see the notice board at least twice a day for fresh orders or instructions.
17. Night Nurses are expected to rest from 9.30 AM to 4.00 PM except during lecture hours.
18. Silence should be maintained in the College premises during office hours.
19. In sickness students should report to the College during working hours and to the Home Sister on duty after working hours or on holiday for appropriate action. Students should not approach the Doctors directly.
20. Students on vacation are not allowed to stay in the hostel without the prior consent of the Principal.
21. Student's mail will be kept in the rack in the hostel meant for this purpose.
22. Students are not allowed to roam around aimlessly in the Hospital in Mufti.
23. Pets are not permitted in the Hostel

MAINTENANCE OF DISCIPLINE AMONG STUDENTS OF THE UNIVERSITY

Ordinance XV-B

1. All power relating to discipline and disciplinary action are vested in the Vice- Chancellor.
2. The Vice-chancellor may delegate all or such powers as he/she deems proper to the proctor and to such other persons as he/she may specify in this behalf.
3. Without prejudice to the generality of power to enforce discipline under the ordinance, the following shall amount to act of gross indiscipline.
 - a. Physically assault or threat to use physical force, against any member of the teaching and non-teaching staff of any Institution/department and against any student within the University of Delhi.
 - b. Carrying of, use of, or threat of use of any weapons.
 - c. Any violation of the provision of the Civil Rights Protection Act, 1976.
 - d. Violation of the status, dignity and honour of students belonging to the scheduled castes and scheduled tribes.
 - e. Any practice, whether verbal or otherwise derogatory of women.
 - f. Any attempt at bribing or corruption in any manner.
 - g. Willful destruction of institution property,
 - h. Creating ill will of intolerance on religious or communal grounds.
 - i. Causing disruption in any manner of the academic functioning of the university system.
 - j. Ragging as per ordinance XV-C.
4. Maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Vice-chancellor, may in the exercise to his/her powers aforesaid order or direct that any student or students:
 - (a) Be expelled or
 - (b) Be, for a stated period, rusticated or
 - (c) Be, not for a stated period, admitted to a courses or courses of study in college, department or institution of the University; or
 - (d) Be, fined with a sum of rupees that may be specified or
 - (e) Be, debarred from taking a University / College or Departmental Examination or examination for one or more years; or.
 - (f) that the result of the student or students concerned in the Examination or Examinations in which he/she or they have appeared be cancelled.
5. The Principal of the College, Head of the Halls, Dean of Faculties, heads of teaching Departments in the University, the Principal, School of Correspondence Courses and continuing Education and Librarian shall have the authority to exercise all such disciplinary powers over students in their respective Colleges institutions. Faculties and Teaching Departments in the University as may be necessary for the proper conduct of the Institution, Hall and teaching in the concerned Departments. They may exercise their authority through, or delegate authority to, such of the teachers in their colleges, Institutions or Departments as they may specify for these purposes.

6. Without prejudice to the powers of the Vice-chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed. These rules may be supplemented, where necessary, by the Principals of Colleges, Heads of halls, Deans of Faculties and heads of teaching departments in this University. Each student shall be expected to provide himself/herself with a copy of these rules.
7. At the time of admission, every student shall be required to sign a declaration that on admission he/she submits himself/herself the disciplinary jurisdiction of the Vice-chancellor and the several authorities of the University who may be vested with the authority to exercise discipline under the Acts, the statutes, the Ordinances and the rules that have been framed therein by the university.

Ordinance XV-C

PROHIBITION OF AND PUNISHMENT FOR RAGGING

1. Ragging in any form is strictly prohibited, within the premises of the College/Department or.
2. Institution and any part of Delhi University system as well as on public transport.
3. Any individual or collective act or practice or ragging constitutes gross indiscipline and shall be dealt with under this ordinance. Ragging for the purposes of this ordinance, ordinarily means any act conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts or practices which:
 - (a) Involve physical assault or threat or use of physical force.
 - (b) Violate the status, dignity and honour of woman students.
 - (c) Violate the status, dignity and honour of students belonging to the Scheduled Castes and Scheduled Tribes.
 - (d) Expose students to ridicule on contempt and affect their self-esteem.
 - (e) Entail verbal abuse and aggression, indecent gestures and obscene behavior.
4. The principal of a College, the Head of the Department or an Institution, the Authorities of college, or University Hostel or Halls or residence shall take immediate action on any information of the occurrence of ragging.
5. Notwithstanding anything in Clause (4) above, the Proctor may also suo moto enquire into any incident of ragging and make a report to the Vice-chancellor of the identity of those who have engaged in ragging and the nature of the incident.
6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of ragging incident.
7. If the principal of the College or Head of the department or Institution or the Proctor is satisfied that for some reason, to be recorded in writing, it is not reasonable/practical to hold such an enquiry, he/she may so advise the Vice-chancellor accordingly.
8. When the Vice-chancellor is satisfied that it is not expedient to hold such an enquiry, his/ her decision shall be final.

9. On receipt of a report under Clause (5) or (6) or a determination by the relevant authority under Clause (7) disclosing occurrence of ragging incident described in Clause 3 (a), (b), and (c). that the Vice-chancellor shall direct or order rustication of a student or students for a specific number of years.
10. The Vice-chancellor may in other cases of ragging order, or direct that any student or students be expelled or not to be stated, period admitted to a course of study and results of the student or students concerned in the examination or examinations in which they appeared be cancelled.
11. In case where students who have obtained degrees or diplomas of Delhi University are found guilty under this Ordinance, appropriate action will be taken under status 15 or withdrawal of degrees or diploma conferred by the University.
12. For the purpose of this Ordinance, abetment of ragging will also amount to ragging.
13. All Institutions, within the Delhi University system shall be obligated to carry out instructions/ directions issued under this Ordinance, and to give aid and assistance to the Vice-chancellor or achieve the effective implementation of the Ordinance.

UGC Regulation on curbing the menace of ragging higher educational institution under section 26(1) (G) of the University Grants Commission act 1956

Following measures are taken by the institution to prevent ragging.

1. Written notice expressing that ragging is totally prohibited in institution
2. Those who found guilty of ragging/abetting, ragging, actively or passively or being part of a conspiracy to promote ragging is liable to be punished in accordance with these regulations as well as under the provisions of any penal law for the time being in force.

Class Timing (Study block)

- Monday to Friday 9:00 am to 4:00 pm
- Saturday 9:00 am to 1:00 pm (half day on Saturday)
- Clinical duties 7:30 am to 12:00 Noon
- Lunch break will be from 12:00 pm to 1:00 pm
- Class time during Regular working days 1 – 4 pm

Clinical Duty roster is prepared as per requirement of INC syllabus

- You will get the information before time and display the schedule on notice board.
- Students must adhere to their assigned duty times and report on time to their respective clinical areas in proper uniform with all pocket articles.

PUNCTUALITY AND ATTENDANCE MARKS ALLOCATION

➤ **Punctuality**

- Punctuality is mandatory for both class and clinical duties.
- Late arrivals in clinical will be noted and may affect the student's assessment and grades.

➤ **Attendance Marks Allocation** - Marks will be awarded based on attendance in both clinical and theory classes as follows:

- 95-100% Attendance: 2 marks
- 90-95% Attendance: 1.5 marks
- 85-90% Attendance: 1 mark
- 80-85% Attendance: 0.5 marks
- Below 80% : nil

- Students are not allowed to bring relatives to the OPD during duty hours.
- Violations will be subject to disciplinary action.
- Not to leave the area of posting without prior information to the concerned supervisor
- Daily diary should be completed daily and get it signed by the supervisor in time.

SICK LEAVE RULES

Sick Leave (During Class Time) & duty time

- If a student falls sick between 9:00 AM and 4:00 PM, they must inform the class teacher, **get their health diary written**, and then proceed to the OPD

Sick Leave (During off duty i.e. 4 pm – 9 am)

- If a student falls sick during duty off-hours, they must inform the home sister, **get their health diary written**, and then proceed to the emergency.

Sick Leave (At Home)

- If a student is sick at home, their parents must inform the class teacher
- Upon returning to college, the student must present a medical certificate from a government hospital or dispensary.

LEAVE PROCEDURE

Leave Required during home stay

- For request of leave a letter written by the parents must be sent by post, except in emergencies where parents must call to the class teacher. At the time of admission students from outside Delhi should submit an authorization letter from the parents to visit local guardians.

HSP (Home stay pass) for Leave

- HSP must be taken at least one day in advance and it should be submitted in parents writing to the class teacher.
- **Leave During Working Days**
- Parents/Local guardian must come to the college to request leave for their child during working days.
- Proper documentation and justification for the leave must be provided.

EXAMINATION REGULATIONS (Acc. to INC guidelines)

- A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each course/subject for appearing for examination.
- A candidate must have 100% attendance in each of the practical areas before award of degree.
- Minimum pass marks shall be 40% (P grade/4 point) for English only and elective modules.
