- i. The number of vacancies indicated above are provisionally as per the applicable roster, which may increase or decrease at the time of interview/selection. This is subject to change without any notice,
- ii. Three (3) posts are reserved for Economically Weaker Sections (EWS), where in any recruitment year any vacancy earmarked for EWS category could not be filled up due to non-availability of suitable candidates belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog. A further attempt in the same recruitment year to fill the EWS vacancy is desirable. Thereafter, the unfilled vacancies may be filled up, treating them as unreserved (UR) provided it does not result in excess representation in general category beyond the number added on account of non-availability of EWS candidates.
- iii. Out of 59 vacancies, 04 vacancies (02 current vacancies and 02 carried forward vacancies) are reserved for Persons with Disability who suffer from not less than 40% of disabilities [OL, OA (non surgical) i.e OA, OL, BLCP, LC, DW, AAW, SLD, MD. In case of non-availability of suitable candidates, the carried forward reservation shall be filled by a person other than a person with disability

Terms & conditions of recruitments

1 . **Emoluments:** - Selected candidates will be paid total emoluments of Rs.1,23,500/- per month.

2 . **Essential Qualification: (for Assistant Professor):-** A recognized Medical Qualifications included in the first or Second schedule or part II of the III schedule (other than licentiate qualification) of the Indian Medical Council Act, 1956. Holders of educational qualifications included in part II of the third schedule should also fulfill the condition stipulated in sub section (3) of section (13) of the Indian Medical Council Act, 1956.

- i. Recognized Post Graduate Degree in the concerned specialty or equivalent.
- ii. At least three years teaching experience in a recognized

teaching Institution in the concerned specialty as Lecturer/Tutor/Registrar/Demonstrator/Senior Resident after the requisite postgraduate degree qualification.

Note:

1. **Teaching experience in any post like the post of General Duty Medical Officer/Medical Officer shall not be considered for eligibility purpose for recruitment to teaching posts.**

3. **Age Limit:** not exceeding 40 years. Relaxable for Government Servants, Scheduled Castes, Scheduled Tribes, Other Backward Classes candidates and PWD candidates. Upper age limits up to 5 years is relaxable for Scheduled Castes, Scheduled Tribes, 3 years in the case of OBC candidates and 10 years in case of PWD candidates. Relaxable for Govt. Servants upto five years in accordance with the orders or instruction issued by the Govt.

4. **Reservation:** All Reservations will be considered in the above posts strictly in accordance with prescribed norms/rules as prescribed by Govt. of India.

Note:

- i. SC/ST Candidates must bring community/caste certificate in the prescribed format of Govt. of India.
- ii. OBC Candidates Should submit valid OBC certificate with Non-Creamy Layer certificate issued not later than one year from its issue and as per the instructions/ O.M/guidelines etc issued by the Department of personal & Training, New Delhi. **The sub-caste should be match with the entries in Central Govt. List of OBC, failing which their candidates will not be considered under any of the applied reserved category and will be treated as UR.**
- iii. In respect of candidates of persons with Disabilities category the physical requirements are :
 - A. Medical / Surgical Department: S-can perform work by sitting, ST-can perform work by standing, W-can perform work by walking, SE-can perform work by seeing, H-can perform work by hearing/speaking, RW-can perform work by reading and writing.

- B. For Dental Department: S-can perform work by sitting, ST-can perform work by standing, SE-can perform work by seeing, RW-can perform work by reading and writing, C- can perform work by communication, BN- can perform work by bending, MF- can perform work by manipulating fingers.
- C. Persons with disability to produce a certificate issued by a competent medical authority at the time of Interview. i v .
Reservation for Economically Weaker Sections (EWS's) shall be applicable as per Govt. of India policy vide DGP&T's Office Memorandum No. 36039/1/2019-Estt(Res.) dated 19.01.2019 and 31.01.2019. candidates who wish to apply against EWS category are required to said **EWS certificate issued in current Financial Year (issued on or before the date of submission of application)**. The benefits of reservation under EWS can be availed only upon production of an Income & Assets certificate issued by a Competent Authority in the prescribed format of Govt. of India.

5. Other terms & Conditions

- i. The appointment shall not confer any right or preference for regular appointment.
- ii. The eligible candidates will have to register themselves for interview from 10.00 am to 11.30 am in the Convocation Hall near Director's Office on the day specified for interview of a particular specialty along with the application duly filled in the prescribed format as per **Annexure-I** with all relevant documents in Original (i.e. Certificate in support of age, educational qualifications, Experience, Medical registration, attempt certificate, mark sheets, conference attended and publications etc.) together with the self-attested copies in support of their candidature for the post.
- iii. No application will be entertained after 11.30 am. Only twenty candidates will be interviewed in a day. In case the number of candidates is more than twenty, then the candidates registered after the 20th number, the interview for such candidates will be held on the subsequent days as per the date and time to be announced at the time of registration (which will be done only on

- the 1st date advertised for the interview for a particular specialty).
- iv. In case regular candidate joins, the appointment shall automatically stands terminated.
 - v. No claim for any service benefit like PF, Pension, Gratuity, Medical Allowance, Seniority & Promotion etc. from this contract appointment will be admissible.
 - vi. No TA/DA will be admissible for interview or joining.
 - vii. Candidates on selection shall be allowed to join only when found medically fit.
 - viii. Mere possession of minimum educational qualification will not automatically confer the right for appearing in the walk-in-for interview. If the number of applications is very large, the competent authority reserves the right to shortlist candidates on the basis of higher qualification/years of experience in the subject.
 - ix. The candidate who is already in Govt. Service should submit "No Objection Certificate" from the Employer at the time of Interview.

JURISDICTION OF ANY DISPUTE:

In case of any legal dispute the jurisdiction of the court will be Delhi/New Delhi.
